

THE MINNEHAHA COUNTY COMMISSION CONVENED IN A JOINT SESSION WITH THE SIOUX FALLS CITY COUNCIL AT 5:00 P.M., August 23, 2022, pursuant to adjournment on August 23, 2022. Commissioners present were: Barth, Bender, Heiberger, and Karsky. Also present was Kym Christiansen, Commission Recorder.

City Council Members present: Barranco, Cole, Jensen, Merkouris, Neitzert, Soehl, and Starr.

Chair Heiberger called the meeting to order.

MOTION by Karsky, seconded by Bender, to approve the agenda. By roll call vote: 4 ayes. The City concurred.

JOINT BUDGET HEARINGS

Scott McMahon, Metro Communications Director, presented the Metro Communications Agency 2023 budget of \$6,059,153.00. The County's portion for 2023 is \$697,937.00 and the City's portion is \$2,093,815.00. MOTION by Karsky, seconded by Barth, to approve the 2023 Metro Communications Agency budget as presented. By roll call vote: 4 ayes. The City concurred.

Jodi Fick, Director of Siouxland Libraries, presented the Siouxland Libraries 2023 budget of \$10,746,047.00. The County's portion for 2022 is \$1,405,000.00. The City's portion for 2022 is \$9,341,047.00. MOTION by Barth, seconded by Karsky, to approve the 2023 Siouxland Libraries budget as presented. By roll call vote: 4 ayes. The City concurred.

Bill Hoskins, Museum Director, presented the Siouxland Heritage Museums 2023 budget. The requested Operations Budget is \$1,511,574.00, to be split equally between the City of Sioux Falls and Minnehaha County. The City of Sioux Falls will provide \$38,560.00 for the Pettigrew Home and Museum Maintenance. Minnehaha County will provide \$61,000.00 for the Old Courthouse Museum Maintenance. The Irene Hall Museum Resource Center requested maintenance budget is \$50,900.00 and will be equally funded by both the City of Sioux Falls and Minnehaha County. The proposed budget also includes the Museum Special Enterprise Fund at \$207,250.00 and the Museum Store Fund at \$21,950.00. MOTION by Bender, seconded by Barth, to approve the 2023 Museum Operations, Pettigrew Home and Museum Maintenance, Old Courthouse Museum Maintenance, Irene Hall Museum Resource Center Maintenance, Museum Special Enterprise Fund, and Museum Store Fund budgets as presented. By roll call vote: 4 ayes. The City concurred.

PUBLIC COMMENT

Dennis Hogan, Sioux Falls, spoke about how safe the community is and what a good job the City of Sioux Falls and Minnehaha County are doing.

MOTION by Karsky, seconded by Barth, to adjourn. 4 ayes.

The Commission adjourned until 9:00 a.m. on Tuesday, September 6, 2022.
